  - A SELF ADDRESSED STAMPED (not metered) ENVELOPE for return of photo.
  - PHOTO OF DOG. If photo is digital, include a print labeled with dog's name plus photo on disc or CD. No emailed photos.

HEALTH TESTING MUST COMPLY WITH PWDCA AD POLICY (effective December 20, 2006): "Dogs being used for breeding must have an OFA#, a current CERF# up to 120 months of age (a dog rated OptiGen C or C1 or Affected can be featured in a breeding related ad provided it has a current CERF exam form with a sole diagnosis of PRA as the reason for failure), be OptiGen tested, and be individually tested at NYU for GM1 and have a GM1 rating of GM1: NOR, GM1: CAR, N99, N99A, N99L, N95, N95A, N95L, C99, C95, IND or an AP rating.

"When advertising the frozen semen of a deceased dog, health certifications must have been in accordance with the PWDCA breeding-related advertising policy in effect at the time of the dog's death."
